# PARTICIPANT'S ACKNOWLEDGEMENT OF RISK STATEMENT

## **INCLUDING WAIVER, RELEASE & INDEMNITY**

The Correct completion of the Australian Formula Jetsprint Association Acknowledgement of Risk Statement is a vital part of our racing event documentation. It is important that all Participants entering Restricted Areas accept that there is a risk of injury or death by signing this document before being issues with credentials/passes.

Restricted Access include the entirety of the pits from the gate to the track, including the racing track, and surrounds. This sheet must remain the responsibility of one Official, who must sight all entries made by each Participant in the appropriate columns and then complete the statement.

- 1. Always use the right forms forms may change from time to time. Venue management should ensure that Official's are issued with the current version.
- 2. Use a pen all entries must be made in ink The Official must ensure that the Participants name is clearly printed. Where the detail is unsatisfactory, the Official should place a horizontal line across the complete line, initial the cancellation, and direct the Participant to use the next line.
- 3. Keep the entire sheet in view While in use, it is important that the sheet is not folded in any way. Do not fold the form in half or lay it over the edge of the counter or table for convenience. The statement on the left side of the sheet should be in plain view of the Participant while the left columns are being completed. Copies of the statement should be available for people to consider before signing if they wish, or to keep as a record. The Officials should ask each Participant whether they have read and understood the statement before signing.
- 4. Establish a regular point for credential issue/sign in Wherever possible, all forms should be signed at the same place at every event (breatho's). Do not pass the statement into vehicles for people to sign. Each signatory must clearly complete and sign the form in sight of the Official. At least one clearly visible sign stating the purpose of the procedures should be used.
- 5. Used the trained officials at the signing place It's important that people know what they are signing.

Participants must be told that they are signing a waiver, release and indemnity document.

Officials overseeing completion of the statements should be able to answer basic questions on the content of this form, and the commitment people are making in signing it. Comments like "you have to sign this, or we can't issue you with a pass", or any effort to rush people through without giving them an opportunity to read the waiver, is not acceptable.

- 6. Take extra care with forms signed on behalf of minors A minor is anyone under the age of eighteen (18) years. This waiver will need to be signed by a parent/guardian on behalf of a minor, and under no circumstances should a signature of a minor be accepted.
- Store the complete Acknowledgement of Risk sheets carefully As with most important documents, these forms should be kept for at least seven (7) years. The forms may be folded for storage but only with the statement and signature on the inside. The forms can be stored in an electronic format.
- 8. Ensure that their medical clearance has been received prior to signing.

2. The Activity:	Principally Jet Sprint Racing, administrators, organisers & promoters of Jet Sprint racing and related, permitted

3. The Risks of the Activity: Risk of being hit by a boat, or hitting another boat, risk of being hit by debris from boats, or surface, risk of colliding with safety barriers/fencing or other fixed or moveable objects, risk of crashing due to the surface of the track and surrounds of the track, risk of being burnt or suffering physical or psychological injury, risk of crashing due to debris being on the track, risk of injury through acts of violence or other harmful acts committed by person attending or participating in the event, risk of slipping of falling, risk of any physical or psychological injury that is a result of participating in Jetsprint racing.

4. Medical Declaration: I declare that I have obtained a Medical Clearance, following a physical examination by my doctor, to undertake participation in the Activity ("Medical Clearance") and after careful consideration I declare that I am not subject to any existing injury, medical condition or treatment that may render me unsuitable for participation in the Activity, or which may be negatively impacted by my participation in the Activity. I have provided a copy of my Medical Clearance to the AFJSA for this event.

#### 5. Acknowledgements: I acknowledge that:

- a. I am the Participant being supplied with a recreational service by the Business
- b. The Activity is a dangerous recreational activity, which involves a significant risk of physical harm.
- c. I may be injured as a result of my participation in the Activity.

- d. My personal property may be lost, damaged or destroyed as a result of my participation in the Activity
- e. Other people may cause me injury or may damage my property in the course of my participation in the Activity.
- f. I may cause injury to myself or other persons or damage my property or the property of others in the course of my participation in the Activity.
- g. The natural conditions in which the Activity is conducted may vary without warning.
- h. My participation in the Activity is voluntary and I have not been required by the Business to engage in the Activity.
- i. I have disclosed any pre-existing medical or other condition that may affect the risk that either I or any other person will suffer injury, loss or damage.
- j. The Business relies on the information provided by me and I state that all such information is accurate and complete.
- k. I am aware of the dangers associated with the consumption of alcohol, mind altering substance, drug or other substance which may impair my judgment or physical ability or capacity to safely participate in the Activity and accept full responsibility for any injury, loss or damage associated with my consumption of alcohol, mind altering substance, drug or other substance which impairs my judgment, physical ability or capacity to safely participate in the Activity.
- I. I have not relied upon any advice, representations or inducements by or on behalf of the Business in deciding to participate in the Activity or in deciding to sign this document.

- d. The Business has placed signs around the site on which the Activity is to be performed warning of the risk of injury. I have read the signs and understand the warnings provided.
- e. The Business has provided me with warnings of the Risks associated with the Activity and the risks of physical or psychological hard in participating in the Activity.
